**AMENDMENT N° 05 - CONTRACT N° 70200/20-04/00**

AMENDMENT No. 05 TO CONTRACT No. 70200/20-04/00 SIGNED BETWEEN THE BRAZILIAN NAVAL COMMISSION IN WASHINGTON AND SCHENKER INC. FOR THE PROVISION OF NATIONAL AND INTERNATIONAL FREIGHT SERVICES, INCLUDING LAND, MARITIME AND AIR TRANSPORT, WITH INSURANCE COVERAGE.

The Brazilian Federal Government, through the Brazilian Naval Commission in Washington (BNCW), Brazilian Navy, located at 5130 MacArthur Blvd., N.W., Washington, DC, 20016, represented herein by his President, **CAPT ALEXANDRE VIZEU DIAS**, holder ID N° 536.541-4, hereinafter referred to as **CONTRACTING PARTY** and the company SCHENKER INC., represented by **Mr. DAVID BUSS**, holder of Driver's License N° B200-172-4182, with main office located at 1305 Executive Blvd., Suite 200, Chesapeake, VA 23320, hereinafter referred to as **CONTRACTED PARTY**, in compliance with the provisions of Law No. 8.666, of June 21, 1993, Law No. 10.520, of July 17, 2002, and Decree No. 10.024, of September 20, 2019, adapted to local peculiarities, resolve to enter into this Amendment to Contract No. 70200/20-04/00, through the clauses and conditions set out below:

**1. CLAUSE - OBJECT**

1.1 This Amendment's object remains unchanged, detailed in clause 02 of contract 70200/20-04/00, as provided in item II of article 65 of Law No. 8.666/1993.

**2. CLAUSE - CONTRACT AMOUNT**

2.1 The costs of services, detailed in clause 4.1, have been reassessed to economically and financially optimize the Contract. Consequently, the Annex attached to this Amendment has superseded the table in item 3.3 of Contract Amendment No. 70200/20-04/04.

2.2 As a result of the economic and financial optimization of the cost of services, the Contract amount estimated in clause 9.3 has been changed to **USD 62,529.22**.

**3. CLAUSE - BUDGET ALLOCATION**

Contract No. 70200/20-04/00 - Amendment No. 05

3.1 Expenses to attend this Contract are programmed in a specific budget allocation, foreseen in the Union budget for the 2024 fiscal year, in the classification below:

#### 6. CLAUSE - FINAL DISPOSITIONS


6.1 All other clauses and provisions of Contract 70200/20-04/00 and its Amendments will remain the same as long as they do not contradict these terms.


