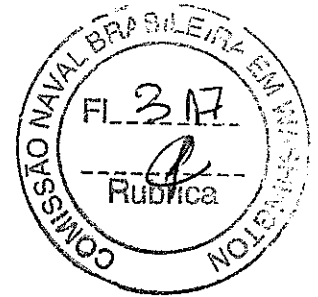

AMENDMENT 1

Amendment 1 to Contract 70200/21-02/00, entered between the Brazilian Naval Commission in Washington and Jackpot Janitorial & Commercial Services LLC for cleaning and maintenance of BNC'S building common areas.

This first Amendment to the Contract number 70200/21-02/00, for cleaning and maintenance of the Brazilian Naval Commission in Washington (BNC) building common areas, represented by Captain JOSÉ AUGUSTO CORREIA NETO, President, holder of the Brazilian Naval Commission, ID 629980-6, and Jackpot Janitorial & Commercial Services LLC, represented by Jamol Speight, Director of Operations, holder of ID # 0112988, with office located at 200 Massachusetts Avenue NW Suite 700, Washington D.C 20001.

WHEREAS the present Contract fulfilled all legal requirements of Brazilian article 123, combined with item II of article 57 of the Law 8.666/1993

WHEREAS the legal instruments Rules for Administrative Agreements of the Brazilian Navy, issued by the Commander of the Navy, granted authority to the President of the Brazilian Naval Commission in Washington, to sign this Contract on behalf of the Brazilian Navy within its area of jurisdiction.

WHEREAS this Amendment reflects the will of the parties.

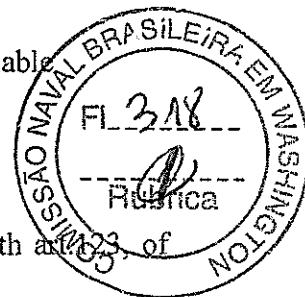
THEREFORE, in consideration of the foregoing, the execution of this agreement by each of the parties hereto, and full and faithful performance of the covenants, representations and warranties contained herein, it is agreed the following amendments to Contract 70200/21-02/00:

CLAUSE 1- OBJECT

Clause 2.3.1, Semi-Annual Services, Annual Services and clause 2.5 Supplies of the Contract 70200/21-02/00, will be changed to the following:

The Semi-Annual Services will be reduced to only an Annual Service, which will include one carpet cleaning per year, and replacing the cleaning of all exterior glass surfaces from the contract.

Supplies: BNC will be responsible to furnish all cleaning agents and consumable products.



CLAUSE 2 – VALIDITY

This is a Term Amendment, based on item XI of article 57, combined with article 3 of Law N°. 8666/1993, effective from May 10th, 2022 to May 10th, 2023.

CLAUSE 3 – PRICE

The annual value of the contract 70200/21-02/01, is USD 43,200.00, as per the quotation attached to this Amendment.

CLAUSE 4 – PROTECTION OF PERSONAL DATA

The Provider undertakes to comply with the General Law for the Protection of Personal Data (LGPD), Law N° 13.709, of August 14, 2018, where the processing activities of data, received as a result of this contract, must observe the principles of purpose, adequacy, necessity, open access, data quality, transparency, security, prevention, responsibility and accountability.


Sole paragraph - the sharing of personal data, arising from this contract, must meet only the agreed object, and the Provider is responsible for any deviations from the agreed purpose.

CLAUSE 5 - FINAL DISPOSITIONS


All other clauses and provisions in the contract shall remain the same.
