AMENDMENT N° 06**

Amendment N° 06 to Contract 70200/20-01/00, signed between the Brazilian Naval Commission in Washington (BNCW) and Copacabana Catering LLC for preparing and delivering meals to the BNCW offices.

The Brazilian Federal Government, through the Brazilian Naval Commission in Washington (BNCW), Brazilian Navy, located at 5130 MacArthur Blvd., N.W., Washington, DC, 20016, represented herein by his President, CAPT ALEXANDRE VIZEU DIAS, holder of Brazilian Navy Identification Card n° 536541-4, hereinafter referred to as CONTRACTING PARTY and the company COPACABANA CATERING LLC, represented by its Owner, Mr. FRANCISCO NARCISIO SALES CARVALHO, holder of ID N° USCIS 200-420-486/IR6, with main offices located at 10562 Metropolitan Avenue, Kensington, MD 20895, hereinafter referred to as CONTRACTED PARTY, in view of what is stated in Process N° 63150.002717/2019-19, in compliance with the provisions of N° 8.666, of June 21, 1993, adapted to local peculiarities, hereby decide to enter into this Contract Amendment, resulting from the Online Reverse Bid Auction N° 13/2019, through the clauses and conditions set out below.

1. CLAUSE - OBJECT

1.1 The purpose of this Amendment is to adjust the value and term of duration, and establish the reference number of a minimum of 25 and maximum of 50 daily meals verified the week prior.

1.2 Regarding clause 7.1, the maximum total amount of the Contract is amended to USD 198,000.00 for 9 (nine) months.

1.3 Regarding clause 11.1, the Contract's term of duration is amended and shall remain in effect from April 3rd, 2024, to January 16 th, 2025.


4. CLAUSE - FINAL DISPOSITIONS
