**AMENDMENT 01 (70200/18-02/18-01)**

**THIS IS THE AMENDMENT 1 TO THE CONTRACT BETWEEN THE BRAZILIAN NAVAL COMMISSION IN WASHINGTON AND JOANN ROBERTSON, SOLE PROPRIETOR OF ENGLISH LANGUAGE EDUCATIONAL SERVICES, TO EXTEND THE TERM AND TO ADJUST THE PRICE.**

This Amendment N° 1 to the Contract **70200/18-02/18** was entered on this March 1, 2019 at the offices of the Brazilian Naval Commission in Washington, between the Brazilian Naval Commission in Washington, herein represented by the President, André Luís Ferreira da Silva, holder of passport number DB038908, with offices at 5130 MacArthur Boulevard NW, Washington, DC, 20016-3316, Joann Robertson, Sole Proprietor for English Language Educational Services, holder of Employer's FED ID N° 52-1530834, whose office is 4706 Chestnut Street, Bethesda, MD 20814.

**WHEREAS** the present Contract fulfilled all legal requirements of Brazilian Law n° 8.666/93 and its amendments.

**WHEREAS** the legal instruments Rules for Administrative Agreements of the Brazilian Navy (SGM-258/MB/2003, n° 111/MB/2004, n° 258/MB/2012, n° 159/MB/2013 and n° 626/MB/2014, issued by the Commander of the Brazilian Navy, granted authority to the President of the Brazilian Naval Commission in Washington, DC to sign this Contract on behalf of the Brazilian Navy within its area of jurisdiction.

**WHEREAS** this Amendment reflects the will of the parties.

**THEREFORE**, in consideration of the foregoing, the execution of this agreement by each of the parties hereto, and the full and faithful performance of the covenants, representations and warranties contained herein, it is agreed the following amendments to Contract **70200/18-02/18**.

**CLAUSE 1 – OBJECT OF THIS AMENDMENT**

- a. Extension of the validity of the Contract for an additional period of 6 (six) months, from March 1<sup>st</sup> to August 31<sup>st</sup> of 2019.
- b. Increasing of the monthly payment to US\$1,083.33 to the total price of US\$ 6,500.00 for the 6-month period.

**CLAUSE 2- EFFECTIVE DATE**

This Amendment shall be in effect and enforceable for the 6-month period from March 1<sup>st</sup> to August 31<sup>st</sup> of 2019.

**CLAUSE 3 – APPENDIX**


The Appendix "A" of the original contract (Request for Service) shall maintain a constitutive part of the contract.

**CLAUSE 4 - FINAL DISPOSITIONS**


All other clauses and provisions in the contract shall remain the same.


