AMENDMENT 4 (Contract 70200/19-03/04)

Amendment 4 to Contract 70200/19-03/00, signed between the Brazilian Naval Commission in Washington and USI Insurance Services LLC for the Health, Dental and Vision insurance.

The Brazilian Federal Government, through the Brazilian Naval Commission in Washington (BNCW), Brazilian Navy, located at 5130 MacArthur Blvd., N.W., Washington, DC, 20016, represented herein by his President, **CAPT ALEXANDRE VIZEU DIAS**, holder ID N° 536.541-4, hereinafter referred to as **CONTRACTING PARTY** and the company **USI INSURANCE SERVICES LLC** (United Health Care Global), represented by its Vice-President, Mr. David Masri, holder of the Virginia State ID N A69-63-1158, hereinafter referred to as **CONTRACTED PARTY**, with offices at 3190 Fairview Park Drive, Suite 400, Falls Church, VA 22042, in compliance with the provisions of Law No. 8.666, of June 21, 1993, Law No. 10.520, of July 17, 2002, and Decree No. 10.024, of September 20, 2019, adapted to local peculiarities, resolve to enter into this Amendment to Contract No. 70200/19-03/00, through the clauses and conditions set out below:

1. CLAUSE 1- OBJECT

1.1 This Amendment's purpose is to adjust the price and term of duration.

1.2 The Object of this Amendment remains unchanged, being detailed in clause 02 of the contract 70200/19-03/00.

2. CLAUSE - APPLICABLE LAW

2.1 This Amendment is based on item II of Article 57, combined with item II, letter "d" of Article 65, in line with Article 123 of Law N° 8.666, of June 21, 1993.

3. CLAUSE - VALIDITY

3.1 The term of validity of this Term of Contract starting on the date of 06/22/2023 and ending on 06/22/2024, extendable pursuant to item II of article 57, combined with art.123, of Law N°. 8666/1993, and in accordance with local peculiarities.

4. CLAUSE - PRICE

4.1 The annual value of the contract 70200/19-03/04 was readjusted to USD 421,929,60, as per the quotation attached to this Amendment.



5. CLAUSE - PROTECTION OF PERSONAL DATA

5.1 The Contractor undertakes to comply with the General Law for the Protection of Personal Data (LGPD), Law N° 13.709, of August 14, 2018 Of the Federative Republic of Brazil, where the processing activities of data, received as a result of this contract, must observe the principles of purpose, adequacy, necessity, open access, data quality, transparency, security, prevention, responsibility and accountability.

5.2 The sharing of personal data, arising from this contract, must meet only the agreed object, and the Contractor is responsible for any deviations from the agreed purpose.

6. CLAUSE - FINAL DISPOSITIONS

6.1 All other clauses and provisions in the contract shall remain the same.

7. CLAUSE - COPIES

7.1 To secure and validate what has been agreed upon, this Contract Amendment has been drawn up in two copies of equal content, which the contracting parties have signed after having been read and found to be in order.
