



**AMENDMENT 1  
(70200/19-03/01)**

Amendment 1 to Contract 70200/19-03/00, entered between the Brazilian Naval Commission in Washington and USI Insurance Services LLC for the Health, Dental and Vision insurance.

This first Amendment to Contract number 70200/19-03/00, for the Health, Dental and Vision insurance, represented by Captain André Luis Ferreira da Silva, President, holder of the Brazilian Naval ID N° 440446, and USI Insurance Services LLC, represented by its Vice-President, Mr. David Masri, holder of the Virginia State ID N° A69-63-1158, herein referred to as Provider, with offices at 3190 Fairview Park Drive, Suite 400, Falls Church, VA 22042.

**WHEREA** the present Contract fulfilled all legal requirements of Brazilian Law n° 8.666/1993 and its amendments.

**WHEREAS** the legal instruments Rules for Administrative Agreements of the Brazilian Navy (SGM-102 (Rev.5) and Ordinance n° 180/MB/2001, modified by Ordinances 236/MB/2002, 258/MB/2003, 111/MB/2004, 258/MB/2012, 159/MB/2013 and 626/MB/2014, issued by the Commander of the Navy, granted authority to the President of the Brazilian Naval Commission in Washington, D.C., to sign this Contract on behalf of the Brazilian Navy within its area of jurisdiction.

**WHEREAS** this Amendment reflects the will of the parties.

**THEREFORE**, in consideration of the foregoing, the execution of this agreement by each of the parties hereto, and the full and faithful performance of the covenants, representations and warranties contained herein, it is agreed the following amendments to Contract 70200/19-03/00:

**CLAUSE 1 – OBJECT OF THIS AMENDMENT**

1.1 The Object of this Amendment is:

- a) The extension of the validity of Contract 70200/19-03/00 to an additional period of 12 months;
- b) Price Update - as established in Clause 3 of this Amendment and in the attached quotation presented by the Provider.

1.2 All other terms in the contract will remain the same.



**CLAUSE 2 – EFFECTIVE DATE**

This Amendment shall be in effect and enforceable upon the signature by both parties, and the contract here stated will be valid from July 1<sup>st</sup> of 2020 to June 30<sup>th</sup> of 2021.

**CLAUSE 3 – PRICE**

The annual price of Contract 70200/19-03/01 will be US\$ 419,068.44 (four hundred and nineteen thousand, sixty-eight dollars and forty-four cents) to be paid monthly in the amount of US\$ 34,922.37 (thirty-four thousand nine hundred and twenty-two dollar and thirty-seven cents).

**CLAUSE 4 – APPENDIX**

The Provider quotation with the new prices for the additional 12 months is an Appendix to this Amendm 28<sup>th</sup>

**CLAUSE 5 – FINAL DISPOSITIONS**

All other clauses and provisions in the contract shall remain the same.

It is hereby understood that both parties have accepted the provisions of this Amendment, which was read, agreed and signed by both parties, Captain André Luis Ferreira da Silva, President of the Brazilian Naval Commission in Washington, representing the BNC, and Mr. David Masri representing USI Insurance Service LLC, and witnessed by CDR Raphael Annechino Marques, Head of Purchasing Department at BNC, and Ms. Fari Fayzmehr, USI Insurance Services LLC representative.
