**AMENDMENT 2**

Amendment 2 to Contract 70200/19-03/00, entered between the Brazilian Naval Commission in Washington and USI Insurance Services LLC for the Health, Dental and Vision insurance.

This second Amendment to the Contract number 70200/19-03/00, for the Health, Dental and Vision insurance, represented by Captain JOSÉ AUGUSTO CORREIA NETO, President, holder of the Brazilian Naval Commission, ID 629980-6, and USI Insurance Services LLC (United Health Care Global), represented by its Vice-President, Mr. David Masri, holder of the Virginia State ID N A69-63-1158, herein referred to as Provider, with offices at 3190 Fairview Park Drive, Suite 400, Falls Church, VA 22042.

WHEREAS the present Contract fulfilled all legal requirements of Brazilian Law n 8.666/1993 and its amendments.

WHEREAS the legal instruments Rules for Administrative Agreements of the Brazilian Navy (SGM-102 Rev 5) and Ordinance n° 180/MB, 2001, issued by the Commander of the Navy, granted authority to the President of the Brazilian Naval Commission in Washington, D.C, to sign this Contract on behalf of the Brazilian Navy within its area of jurisdiction.

WHEREAS this Amendment reflects the will of the parties.

THEREFORE, in consideration of the foregoing, the execution of this agreement by each of the parties hereto, and full and faithful performance of the covenants, representations and warranties contained herein, it is agreed the following amendments to Contract 70200/19-03/00:

**CLAUSE 1- OBJECT**

The Object of this Amendment remains unchanged, being detailed in clause 02 of the contract 70200/19-03/00.



## CLAUSE 2- VALIDITY

This is a Term Amendment, based on item XI of article 57, combined with article 123, of Law N°. 8666/1993, effective from July 1, 2021 to June 30, 2022.

## CLAUSE 3 – PRICE

The annual value of the contract 70200/19-03/01, with a value of USD 376.118.52, as per the quotation attached to this Amendment.

## CLAUSE 4 – PROTECTION OF PERSONAL DATA

The Provider undertakes to comply with the General Law for the Protection of Personal Data (LGPD), Law N° 13.709, of August 14, 2018, where the processing activities of data, received as a result of this contract, must observe the principles of purpose, adequacy, necessity, open access, data quality, transparency, security, prevention, responsibility and accountability.


Sole paragraph - the sharing of personal data, arising from this contract, must meet only the agreed object, and the Provider is responsible for any deviations from the agreed purpose.


## CLAUSE 5 - FINAL DISPOSITIONS
