Contract N° 70200/21-02/03

Amendment N° 03 to Contract 70200/21-02/00, signed between the Brazilian Naval Commission in Washington (BNCW) and and Jackpot Janitorial & Commercial Services, LLC for cleaning and maintenance of BNCW's building and common areas.

The Brazilian Federal Government, through the Brazilian Naval Commission in Washington (BNCW), Brazilian Navy, located at 5130 MacArthur Blvd., N.W., Washington, DC, 20016, represented herein by his President, **CAPT ALEXANDRE VIZEU DIAS**, holder ID N° 536.541-4, hereinafter referred to as **CONTRACTING PARTY** and the company JACKPOT JANITORIAL & COMMERCIAL SERVICES, LLC, represented by **Mr. JAMOL SPEIGHT**, Director of operations, holder of ID N° 0112988, with main office located at 1100 15th Street NW, Suite 400, Washington, DC 20005, hereinafter referred to as **CONTRACTED PARTY**, hereby decide to enter into this Contract Amendment, through the clauses and conditions set out below:

1. CLAUSE - OBJECT

- 1.1 This Amendment's purpose is to adjust the term of duration.
- 1.2 Regarding clause 4.1, the maximum total amount of the Contract is amended to USD 8,400.00, for 2 (two) months;
- 1.3 Regarding clause 17, the Contract's term of duration is amended and shall remain in effect **from May 11th, 2024, to July 10th, 2024.**

2. CLAUSE - APPLICABLE LAW

- 2.1 This Amendment is based on item II of Article 57, combined with item II, letter "d" of Article 65, in line with Article 123 of Law N° 8.666, of June 21, 1993.

4. CLAUSE - TERM OF VALIDITY

4.1 The Term of Validity of this Amendment remains in effect for the duration spanning from **May 11th, 2024, to July 10th, 2024**, with the possibility for extension in conformity with Subsection II of Article 57, read in conjunction with Article 123 of Law No. 8666/1993, subject to local peculiarities.

5. CLAUSE - PUBLICATION




6. CLAUSE - FINAL DISPOSITIONS
